General Policies

1. All purchases are final and non-transferable. No refunds, credits or substitutions of any kind will be issued if you fail to use or take possession of your Season Pass or Frequent Player Card.
2. Season Passes or Frequent Player Cards are non-transferable and may not be loaned to anyone, except for the Corporate Pass. Transfer, or attempt to transfer will result in revocations of the Pass/Card without refund and is punishable under Pennsylvania theft of services law.
3. If your Pass/Card is lost, report the loss immediately to resort management. Your Pass/Card will be voided and anyone caught using it will be charged with theft of services. A new Pass/Card will be issued to you for a \$25 processing fee.
4. Season Pass and Frequent Player privileges may be denied, revoked or suspended at any time for any reason deemed appropriate by Whitetail Golf Resort Management.
5. Season Pass Holder and Frequent Player will be responsible for any damage caused to the golf cart while in
6. Junior golfers 16 years of age and older with a registered driver's license will be permitted to drive golf carts. I agree that all disputes arising under this release and/or from my or my minor child's use of the facility at Whitetail shall be litigated exclusively in the Court of Common Pleas of Franklin County, PA or in the United States District **Court for the Middle District of Pennsylvania. If any provision of this agreement is determined to be unenforceable,** all other provisions shall be given full force and effect.
